

# Nimbus International Company Private Limited: Rating placed on 'Issuer Not Cooperating' category with notice for withdrawal

## **Rating action**

ICRA Nepal has revised the short-term loan rating of Nimbus International Company Private Limited (NICPL) to [ICRANP] A4 'Issuer Not Cooperating' (pronounced ICRA NP A four, Issuer Not Cooperating) from [ICRANP] A4 (pronounced ICRA NP A four). The rating action has been taken in accordance with the Credit Rating Regulations 2011, following lack of timely cooperation from NICPL for rating information despite multiple follow-ups. The rating has also been put on notice for withdrawal.

#### **Rationale**

The rating revision mainly factors in the uncertainties regarding the company's financial and operational profile, amid the lack of timely/adequate information about NICPL's performance and hence the resultant concerns around its credit risk. These concerns are further heightened by the inflated borrowing rates during last 12-15 months, raw materials price volatility along with the company's stretched financial profile and weak operational profitability, when last rated. The ongoing economic slowdown might have further impacted NICPL's operational and financial indicators. However, in lack of timely/adequate information from NICPL, the exact extent of the impact on the company's financial profile and debt coverage indicators could not be ascertained.

ICRA Nepal assesses whether the information available about the entity is commensurate with its rating and reviews the same as per Credit Rating Regulations 2011 as well as ICRA Nepal's 'Withdrawal/Suspension Policy' available at <a href="https://www.icranepal.com">www.icranepal.com</a>.

As a part of its process and in accordance with its rating agreement with NICPL, ICRA Nepal has been trying to seek comprehensive information from the entity to monitor its performance, but despite repeated requests by ICRA Nepal, the entity's management remained largely non-cooperative till the extended deadline for surveillance. In the absence of the requisite information on a timely manner and in line with the aforesaid policy of ICRA Nepal, a rating view has been taken on the entity based on the best available information.

For such ratings, the lenders, investors, and other market participants are advised to exercise appropriate caution while using the ratings as it may not adequately reflect the credit risk profile of the entity. The entity's credit risk profile may have changed to a level greater than that represented by the rating symbol.
